

PARTICIPANT CODE OF CONDUCT

The Spanish Fork Parks & Recreation Department promotes respect, kindness, integrity, good behavior and fair play in all of its programs. We have an ongoing concern about keeping a high standard of behavior in each of our programs. Participants, volunteers and parks and recreation staff (i.e. directors, teachers, instructors, supervisors) should all be able to feel they are in a "safe" environment when they are participating or working. We desire that all participants in our programs be aware of our **"Participant Code of Conduct"** before choosing to participate in the city's parks & recreation programs (i.e. classes, lessons, camps, clinics, events or activities).

Spanish Fork Parks & Recreation has established the following **"Participant Code of Conduct"** for all persons involved in any of our programs. All participants are expected to know, promote and adhere to the following standards of conduct. This code of conduct will apply in all of our parks & recreation programs.

1. I will encourage good behavior from fellow participants, staff and parents/legal guardians at every activity by demonstrating good behavior.
2. I will attend every scheduled part of the program I'm involved in that is reasonably possible and will notify the staff if I cannot.
3. I will expect to receive a fair amount of instruction.
4. I will do my best to listen, have fun and learn from the staff and volunteers. I will do my best to try to help others be successful and have a good experience.
5. I will treat other participants, staff, volunteers and spectators with respect regardless of race, sex, creed or abilities and I will expect to be treated accordingly.
6. I will take care of any supplies, costumes or props that are issued to me. I will return any borrowed items.
7. I will help in cleaning the area after the program each time we meet, keep things organized and make sure no trash is left behind.
8. I understand that aggressive behavior or inappropriate language will not be tolerated and may be cause for removal from any parks & recreation program and/or permanent suspension from participation.
9. I will not bully or mistreat any other participant, staff or volunteer.
10. I deserve to have fun during my experience and will alert my parents, teacher or staff if it stops being FUN!
11. I deserve to participate in an environment free of alcohol, tobacco, and drugs and expect fellow participants, staff and volunteers to respect that wish.
12. I will encourage my parents/legal guardians to be involved with my program in some capacity because it's important to me.
